- d) Bids must be valid for a period of 60 days after opening of bid documents and must be accompanied by a minimum bid security of 2.5% of quoted amount (Including VAT) valid for 30 days beyond the bid validity period. If bidder wishes to submit the cash security the cash should be deposited in Deposit Account Number 00600303340012 at Himalayan Bank Limited, Pulchowk, Lalitpur and submit the receipt of the cash deposited amount along with a bid.
- e) Bid Documents shall be opened on October 05, 2021 in the presence of bidder representatives who choose to attend at 14:00 Hrs. (SN 1), 14:30 Hrs. (SN 2), 15:00 Hrs. (SN 3), 15:30 Hrs. (SN 4) and at 16:00 Hrs. (SN 5). However, absence of bidders shall not cause restriction on opening of the bid.
